- I. The meeting was called to order by President Humes at 4:30 pm.
 - A. Members Present: President Harry Humes, Secretary LeAnn Millar, Treasurer/Membership Director Liz Touhey, Event Co-Director Sonya Backovich, Members-at-Large Keith Sweet and Alan Rush.
 - B. Members Absent: Vice President Rae Rasmusson, Event Co-Director Rena Snyder and Member-at-Large Vance Wilson.
- II. Review and Approve Minutes
 - A. L. Touhey moved/L. Millar seconded to approve the March 24, 2026 board meeting minutes. The motion carried unanimously.
- III. Treasurer's Report
 - A. L. Touhey presented the March and April 2026 treasurer's report. A. Rush moved/K. Sweet seconded to approve the March and April 2026 treasurer's reports. The motion carried unanimously. A copy of the reports is in the APC binder.
- IV. New Business
 - A. H. Humes secured court repair supplies from K. Sweet which were left-over supplies from previous repair work and filled the court cracks.
 - B. L. Touhey requested that a petty fund be implemented for small expenditures. After discussion, K. Sweet moved that a \$100 Petty Fund be placed in the budget. A. Rush seconded. The motion carried unanimously.
 - C. L. Millar donated envelopes and stamps for current club needs.
- V. Old Business
 - A. K. Sweet informed the board that the Community Foundation Grant was unsuccessful for the purchase of bleachers for the Detert Park pickleball courts.
 - B. The pickleball fundraiser is June 13, 2026. S. Backovich has released flyers to members and left copies at various courts in the area. The entry fee is \$25 and this is a 20/80 split with Mainstreet Theatre Company to support the production of the play, Pickleball.
 - C. L. Touhey gave an update on the lone courts. She and K. Sweet will attend the lone Parks and Recreation meeting and she plans to speak during the open comments section regarding the lone baseline and sideline safety court concerns and suggest possible remedies.
 - D. L. Millar gave an update on agenda items for the upcoming general meeting. Agenda items include bylaw changes, VP nomination, Secretary

nomination, approval of the budget for next year, approval of last year's minutes, and club night at the Pickleball play on July 17, 2026.

- A. Current Membership reported by L. Touhey is 73 active members.

VII. Activity Report

- A. S. Backovich will direct the Pickleball play fundraiser and has asked L. Touhey to assist with the scoring. L. Touhey happily agreed.
- B. S. Backovich and Sue Duncan of Sutter Creek Mainstreet Theatre Company were interviewed by local radio station KVGC regarding the upcoming fundraiser for the play, Pickleball. They will be on the radio again in a few weeks.
- C. Final details for the Sutter Creek Mainstreet Theatre fundraiser include bottled water and trail bars for participants as well as a table to purchase tickets to the play, Pickleball.

- A. V. Wilson was not in attendance but sent a text message that he had nothing new to report until he meets with K. Sweet to discuss why the last clinic failed to get enough sign-ups to operate.
